2. Further note that 1,652 shares in NSE were received in auction on July 23, 2015 from the broker. SPA Securities Limited, on account of the shortfall of shares bought back on July 20, 2015.
3. Further note that 100 shares in NSE and 46 shares in BSE were received short from the broker, SPA Securities Limited, from the shares bought back on July 22, 2015 and the auction awaited for the same.
